RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of July 9, 2019 (this “Release”) is made by AB PRIVATE CREDIT INVESTORS LLC, in its capacity as agent and security agent (in such capacity, the “Security Agent”) under that certain Trademark Security Agreement, dated as of September 7, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”) by and among FOURTH LIMITED, a limited liability company incorporated and registered under the laws of England and Wales (the “Grantor”) and the Security Agent. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Pledge and Security Agreement, as applicable.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on September 10, 2018 at Reel 6433, Frame 0842, the Grantor granted to the Security Agent, for the benefit of the Finance Parties, a continuing security interest in and Lien on all of such Grantor’s right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached Schedule A, and all goodwill of the business connected with the use of, and symbolized by, each trademark owned by such Grantor (collectively, the “Trademark Collateral”);


WHEREAS, the Grantor has requested and the Security Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Security Agent in the Released Collateral.
