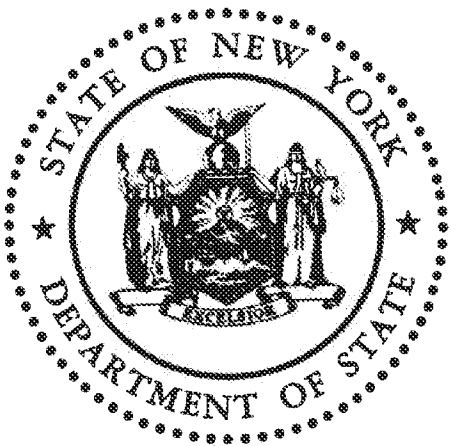

It is hereby certified on May 9, 2019, upon behalf of each of the constituent corporations herein named, as follows:

FIRST: The Board of Directors of each of the constituent corporations has duly adopted a plan of merger setting forth the terms and conditions of the merger of said corporations.

SECOND: The name of the domestic constituent corporation of the merger is E Commerce Group Products Inc., a corporation incorporated in the State of New York as "Lawnet, Inc." on November 13, 1989, which is to be the surviving corporation (the "*Surviving Corporation*").

THIRD: The name of the foreign constituent corporation, which is to be merged into the surviving constituent corporation, is Walletron, Inc. (the "*Merging Corporation*"). The jurisdiction of its incorporation is the State of Delaware, and the date of its incorporation therein is October 31, 2012.

No Application for Authority in the State of New York of the Merging Corporation to transact business as a foreign corporation therein was filed by the Department of State of the State of New York.

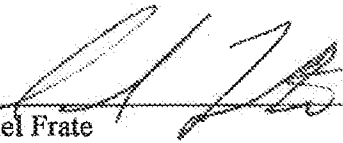

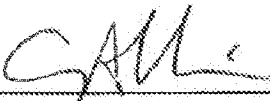
