**TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT
AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the "Release"), dated July 3, 2019, is made by and between The Bryn Mawr Trust Company, as secured lender (the "Lender") and Spray Products Corporation ("Grantor") and recites as follows:

BACKGROUND

A. Pursuant to the Intellectual Property Security Agreement, Form PTO-1594 (Modified) together with its attached Rider and including a Schedule, recorded with the United States Patent and Trademark Office on August 31, 1999 at number 101132714, Reel/Frame No. 001950/0968, the Grantor granted the Lender a Lien on and continuing security interest in, all of its right, title and interest in, to and under the "Trademarks" (as defined therein) pledged by the Grantor described therein, including, without limitation, the United States trademarks set forth on a certain Schedule A attached thereto, which Schedule A is attached to this Release (hereinafter, collectively referred to as the "Released Collateral") and all of the goodwill of the business connected with the use of, and symbolized by the Released Collateral;

B. The Grantor, or its successors and assigns, has paid in full any indebtedness owed to the Lender; and

C. The Grantor, or its successors and assigns, has requested that the Lender release its Lien on and continuing security interest in, all right, title, and interest of the Lender in and to the Trademarks.


AGREEMENT

NOW, THEREFORE, the Lender, without recourse, representation or warranty, and at the Grantor's sole cost and expense, hereby terminates, cancels and releases its Lien on, and continuing security interest in, the Trademarks, including the Released Collateral, and all of the goodwill of the business connected with the use of, and symbolized by the Released Collateral, and any and all right, title and interest of the Lender in the Trademarks shall hereby terminate, cease and become void.

The Lender agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of the Lender's security interest in the Trademarks (without recourse, representation or warranty and at the Grantor's sole cost and expense).
