TRADE MARK ASSIGNMENT

THIS AGREEMENT is made this 19 day of February 2019

**BETWEEN:**

- (1) **EUROPCAR INTERNATIONAL**, registered in France with company number 542 065 305 whose registered office is at 13 ter Boulevard Berthier, 75017 Paris, France (the "Assignor");
- and
- (2) **EUROPCAR MOBILITY GROUP**, registered in France with company number 489 099 903 whose registered office is at 13 ter Boulevard Berthier, 75017 Paris, France (the "Assignee").

**WHEREAS:**

- (A) The Assignor is the registered proprietor of the trade marks listed in Schedule 1 to this assignment (the "Marks").
- (B) The Assignee wishes to purchase the Marks from the Assignor.

**ASSIGNMENT**

1. The Assignor declares that it has good title to and full ownership of the Marks, that it has not granted any security interest over the Marks, and that it is therefore in a position to assign the Marks.
2. The Assignor further declares that, apart from the rights which it currently holds with respect to the Marks, the Assignor does not hold any other rights over the names and logos covered by the Marks.
3. The Assignor further declares that no claim and/or litigation has arisen or is pending concerning the ownership of the Marks.
4. In consideration of the sum of 1 EUR paid by the Assignee to the Assignor (the receipt and sufficiency of which is hereby acknowledged) the Assignor assigns the Marks and transfers to the Assignee all right, title and interest to the Marks together with all rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action.
5. The Assignor agrees that it will at the request of the Assignee at all times hereafter do all such acts and execute such documents as may reasonably be necessary or desirable both to secure the vesting in the Assignee of all rights assigned to it in this agreement and to assist in the resolution of any question concerning the Marks.
6. The Assignor confirms that the Assignee is authorised to sign on behalf of the Assignor all forms and documents that are required by the relevant Trade Marks Registry to record this assignment at that Registry.
7. Any registration costs and/or administration fees applicable shall be borne by the Assignee.



8. This assignment is governed by French law and the Parties agree that the Paris Courts are to have exclusive jurisdiction in relation to any disputes arising in connection with this agreement.




