RELEASE OF TRADEMARK SECURITY AGREEMENT

WHEREAS, pursuant to that certain TRADEMARK SECURITY AGREEMENT, dated as of October 13, 2016 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office on October 13, 2016, at Reel 5899, Frame 0907, COGNATE BIOSERVICES, INC. (the "Releasee"), pledged and granted to OBSIDIAN AGENCY SERVICES, INC., as collateral agent pursuant to the Credit Agreement (the "Releasor"), for the benefit of the Secured Parties a lien on and security interest in and mortgage on all of its right, title and interest in, to and under all of the following Collateral of Releasee:

- A. all Trademarks and Trademark Licenses of Releasee listed on Schedule I attached hereto;
- B. all goodwill associated with such Trademarks and Trademark Licenses;
- C. all Proceeds of any and all of the foregoing; and
- D. all rights to sue for past, present or future infringements thereof; and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Trademark Security Agreement (this "Release") to confirm the release, relinquishment and discharge of its lien on and security interest in and mortgage on all of its right, title and interest in, to and under all such Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

2. Release of Security Interest. Releasor on behalf of itself and the Secured Parties hereby (i) releases, relinquishes and discharges all of its lien on and security interest in and mortgage on the above Collateral, reassigns to the Releasees any and all right, title and interest that it may have, in, to and under the above Collateral and (ii) terminates the Trademark Security Agreement.

3. Recordation. Releasor hereby authorizes Releasee and Releasee's authorized representatives to file this Release at the United States Patent and Trademark Office. The Releasor hereby authorizes and requests an applicable government officer to record this Release.

4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, the parties have caused this Release of Trademark Security Agreement to be duly executed as of February 5, 2018.
