WHEREAS, Assignor is willing to transfer and assign over to Assignee all of Assignor's rights, title and interest in and to the Trademark as set forth herein;


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor and Assignee agree as follows:


1. The Effective Date of this Agreement is June 24, 2019.
