RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of December 22, 2003 ("Effective Date") by and between nSpired Natural Foods, Inc., a Delaware corporation, with its principal office at 14855 Wicks Boulevard, San Leandro, California 94577 ("nSpired"), and US Bank National Association, a national banking association, with its principal office at 555 S.W. Oak Street, Suite 505, Portland, Oregon 97204 ("Grantee").

WHEREAS, pursuant to the terms and conditions of certain security agreements with Grantee, nSpired or one of its predecessors Cool Fruits, Inc., Maranatha Acquisition Corp., Maranatha Holding Corp. and Sunlight Foods, Inc. (collectively with nSpired, the "Grantors"), Grantors granted to Grantee a security interest in and to all of Grantors' trademarks, including without limitation, the registrations and applications set forth on Schedule A attached hereto, together with the goodwill associated therewith (collectively, the "Trademarks"); and

WHEREAS, Grantors have paid all of the outstanding indebtedness to Grantee pursuant to which such security agreements relate.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, cancels and releases any and all security interests it has against the Trademarks.


Grantee shall, at nSpired's expense, take all further actions, and provide to nSpired, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by nSpired to more fully and effectively effectuate the purposes of this Release.
