**PARTIAL RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Partial Release of Security Interest in Trademarks (“Trademark Release”) is made as of July 24, 2019, by **CREDIT SUISSE INTERNATIONAL**, an England limited liability company (the “Collateral Agent”) in favor of **AVAST SOFTWARE S.R.O.**, a Czech Republic limited liability company with an address at Pikrtova 1737/1A, Prague 4, Nusle, Postal Code 140 00, Czech Republic. (the “Grantor”).

W I T N E S S E T H:

WHEREAS, Grantor entered into that certain trademark security agreement dated October 25, 2016 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on January 25, 2017 at the United States Patent and Trademark Office at Reel 5974, Frame 0834.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to its trademarks, including the trademarks listed in Schedule 1 (the “Trademarks”).


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest solely in the Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound and in reliance upon the executed officer’s certificate delivered by the Grantor herewith, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademarks, and assigns, transfers and conveys to the Grantor any interest in such intellectual property, including the Security Interest.
