**TERMINATION AND RELEASE  
OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "**Release**"), dated as of July 25, 2019, by BANCO SANTANDER, S.A., with an address at Gran Via de Hortaleza, 3 - Edificio Pedreña - Planta 1, 28033 Madrid, Spain, as Security Agent (the "**Security Agent**"), in favor of FÁBRICAS AGRUPADAS DE MUÑECAS DE ONIL, S.A.U., a Spanish joint stock company (*sociedad anónima*), with an address at Calle Chile 4, Edificio 1, Planta 2<sup>a</sup>, 28290 Las Rozas, Madrid, Spain (the "**Grantor**"). All capitalized terms used but not defined herein shall have the meaning given to such terms in the Security Agreement (defined below).

WHEREAS, pursuant to the terms of (i) that certain Security Agreement, dated as of December 10, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), among the Grantor and the Security Agent, and (ii) that certain Intellectual Property Security Agreement Supplement, dated as of December 10, 2014 (the "**Intellectual Property Security Agreement**"), between the Grantor and the Security Agent, the Grantor granted to the Security Agent a security interest in and to all of the right, title and interest of the Grantor in and to each trademark owned by the Grantor, whether now owned or existing or thereafter acquired or arising, including, without limitation, the trademarks listed on Schedule A attached hereto, which trademarks are registered in the United States Patent and Trademark Office (the "**Trademarks**"), together with the goodwill of the business connected with the use of, or symbolized by, the Trademarks, and all proceeds thereof and revenues therefrom (together with the Trademarks, the "**Collateral**"), to secure the prompt payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

WHEREAS, the Security Agent wishes to terminate and release its security interest in and to, and reassign and transfer to the Grantor, all right, title and interest of the Security Agent in and to the Collateral, including the Trademarks identified on Schedule A attached hereto; and

WHEREAS, the Intellectual Property Security Agreement was filed on December 17, 2014 with the United States Patent and Trademark Office in Reel: 5420; Frame: 0858.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, as granted under the Security Agreement and the Intellectual Property Security Agreement, and reassigns and transfers to the Grantor all right, title and interest that the Security Agent may have in the Collateral, and terminates the Intellectual Property Security Agreement. The Security Agent hereby authorizes the Grantor, or the Grantor's authorized representative or designee, to record this Release with the United States Patent and Trademark Office.

IN WITNESS WHEREOF, the Security Agent has executed this Release as of the date first set forth above.


