RELEASE OF PATENT, TRADEMARK AND LICENSE SECURITY AGREEMENT

THIS RELEASE OF PATENT, TRADEMARK AND LICENSE SECURITY AGREEMENT ("Release"), dated as of July 30, 2019, is made by U.S. BANK NATIONAL ASSOCIATION, a national banking association ("Lender"), and is as follows:

WHEREAS, PHOENIX TEXTILE CORPORATION, a Missouri corporation ("Borrower"), and Lender are parties to that certain Patent, Trademark and License Security Agreement, dated as of August 28, 2013, which was recorded with the United States Patent and Trademark Office on September 4, 2013 in its records at Reel 5103, Frame 0025 (the "Agreement"); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to Lender a security interest in all of Borrower's right, title and interest in and to all of its Trademarks, including, without limitation: (a) all of Borrower's right, title and interest in and to all of its now or in the future owned or existing Trademarks listed on Schedule I of the Agreement (attached hereto and made a part hereof as Schedule I); (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all Trademarks, including damages and payments for past or future infringements of any and all Trademarks; (d) all rights to sue for past, present and future infringements of any and all Trademarks; (e) all rights corresponding to each of the Trademarks throughout the world; (f) all rights of Borrower as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark applications, including the Trademark Licenses; and (g) together in each case with the goodwill of Borrower's business connected with the use of, and symbolized by, the foregoing; and


WHEREAS, Lender desires to release its rights and security interests in the Trademarks and terminate the Agreement.
