RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of August 5, 2019, is made by and among Gerber Finance Inc. ("Lender") in favor of C&K LLC ("Grantor") as follows:

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Lender; and

WHEREAS, the Grantor has requested that the Lender release its Lien on and continuing security interest in, all right, title and interest of the Lender in and to the Collateral.

NOW, THEREFORE, the Lender, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases its Lien on and continuing security interest in the Collateral, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and any and right, title and interest of the Lender in the Collateral shall hereby terminate, case and become void.

The Lender agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of the Lender's security interest in the Collateral (without recourse, representation or warranty and at the Grantor's sole cost and expense).
