**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is effective as of August 13, 2019, by U.S. BANK NATIONAL ASSOCIATION, as collateral trustee for the secured parties party to that certain Security Agreement dated as of September 17, 2010 among the Grantor (as defined below) and such secured parties (as amended, restated, supplemented or modified from time to time) (in such capacity, the “Secured Party”).

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated as of October 20, 2010 by and between MCS Healthcare Holdings, LLC, a Puerto Rico limited liability company (the “Grantor”, as successor in interest of MCS Medical Card System, Inc.) and the Secured Party (as successor in interest of Jefferies Finance LLC) for the benefit of the Secured Party (as amended, restated, supplemented or modified from time to time, the “2010 Trademark Security Agreement”), the Grantor granted to the Secured Party a security interest in the trademarks listed on Exhibit A hereto (the “Trademarks”);

**WHEREAS**, the 2010 Trademark Security Agreement and its assignment to the Secured Party by Jefferies Finance LLC were recorded with the United States Patent and Trademark Office on October 20, 2010 at Reel/Frame 4301/0051 and January 31, 2013 at Reel/Frame 4953/0791, respectively;

**WHEREAS**, pursuant to that certain Trademark Security Agreement (U.S.), dated as of April 22, 2016, executed by and between Grantor and the Secured Party for the benefit of the Secured Party (as amended, restated, supplemented or modified from time to time, the “2016 Trademark Security Agreement”, and together with the 2010 Trademark Security Agreement, collectively, the “Trademark Security Agreements”), the Grantor granted to the Secured Party a security interest in all of the Trademarks; and


**WHEREAS**, the 2016 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 25, 2016 at Reel/Frame 5776/0800.

**NOW, THEREFORE**, intending to be legally bound hereby, the Secured Party hereby releases and terminates the Secured Party’s security interest in, and all other rights, title and interest in and to, the Trademarks under the Trademark Security Agreements, without any recourse, representation or warranty, and hereby authorizes the Grantor or Grantor’s authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.
