RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of August 23, 2019 (the “Effective Date”), is made by JPMorgan Chase Bank, N.A., in its capacity as Collateral Agent (the “Agent”), in favor of the grantor parties identified on the signature page hereto (each, a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Term Loan Guarantee and Security Agreement, dated as of June 30, 2016, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), each Grantor granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered (i) a Term Loan Trademark Security Agreement, dated as of June 30, 2016 (the “First Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office, (ii) a Term Loan Trademark Security Agreement, dated as of September 2, 2016 (the “Second Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office and (iii) a Term Loan Trademark Security Agreement, dated as of January 26, 2017 (the “Third Trademark Security Agreement” and, together with the First Trademark Security Agreement and the Second Trademark Security Agreement, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, (i) the First Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 5, 2016 at Reel/Frame 5828/0006, (ii) the Second Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 6, 2016 at Reel/Frame 5870/0875 and (iii) the Third Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 15, 2019 at Reel/Frame 6564/0793;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth on Schedule 1 attached hereto, arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels each of the Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to each Grantor and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by any Grantor, at such Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.



