**DECLARATION OF RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

WHEREAS, DecisionOne Corporation, a Delaware corporation, having a place of business at 640 Lee Road, Third Floor, Wayne, Pennsylvania 19087 ("DecisionOne") is the former owner of the trademark registrations listed in Schedule A hereto and incorporated by this reference (the "Trademarks") and the current owner of the copyright registrations listed in Schedule A hereto and incorporated by this reference (the "Copyrights" and, with the Trademarks, the "Intellectual Property").

WHEREAS, DecisionOne and Nationsbank of Texas, N.A. (Dallas) ("Nationsbank") entered into a Security Agreement dated October 1, 1997 (the "Security Agreement"), which was recorded on November 12, 1997 with the United States Patent and Trademark Office ("USPTO") at Reel/Frame 1655/0439 and with the United States Copyright Office ("Copyright Office") at V3407 D002, evidencing Nationsbank's security interest (the "Security Interest") in and to all of the intellectual property collateral identified in the Security Agreement, including but not limited to the Trademarks and the Copyrights;


WHEREAS, DecisionOne assigned the Trademarks to Qantel Technologies, Inc. ("Qantel") pursuant to an Assignment effective December 6, 1999, which was recorded with the USPTO on December 28, 1999, at Reel/Frame 2009/0461;

WHEREAS, Nationsbank, N.A. as successor by merger with Nationsbank of Texas, N.A. (Dallas), assigned its rights in and to the Security Interest to BankBoston, N.A., effective December 22, 1998; BankBoston, N.A. changed its name to Fleet National Bank, which was subsequently acquired by Bank of America, N.A., a United States banking association ("Bank of America"), on June 13, 2005; and

WHEREAS, DecisionOne satisfied all its obligations owed under the Security Agreement to Bank of America, as successor-in-interest to Nationsbank of Texas, N.A.

NOW, THEREFORE, upon knowledge and belief, the Security Agreement is no longer a valid lien against the Intellectual Property and should be recorded as released with respect to the Trademarks and the Copyrights.
