WORLDWIDE ASSIGNMENT OF TRADEMARK RIGHTS

WHEREAS, Tri Marine US Holdings, LLC, a Delaware limited liability company with its registered offices at 2711 Centerville Road, Suite 400, Wilmington, Delaware 19808, United States of America ("Assignor"), is the record owner of the trademark filings and registrations and associated rights that are the subject of this assignment as shown in Exhibits A and B (collectively, the "Trademarks");

WHEREAS, Tri Marine International Pte. Ltd., a private limited company organized under the laws of Singapore, having its principle place of business at 15 Fishery Port Road, Jurong, Singapore 619735 ("Assignee"), desires to acquire all right, title, and interest in and to the Trademarks, and all goodwill and common law rights appurtenant thereto;

WHEREAS, on 2 July 2019, the Assignor entered into a sale, purchase and restructuring agreement whereby, in the context of a broader transaction, Bolton Group S.r.l. acquired the entire participation in Tri Marine Holdings Pte. Ltd, owned by Tri Marine International, LLC and thus becoming, together with Bolton Group BV the sole shareholders of Tri Marine Holdings Pte. Ltd. and, indirectly, of the Assignee (the "Transaction").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby sell, assign, and transfer to Assignee all worldwide right, title, and interest in and to the Trademarks, and the goodwill and common law rights appurtenant thereto, and Assignee does hereby accept this assignment.
2. Assignor agrees to execute all instruments and documents and do such additional acts as necessary to effect, evidence, record, and perfect the assignment and recordation of the rights being assigned hereunder.
3. The Assignor and the Assignee agree that the consideration for the assignment of the Trademarks has been expressly taken into account in the context of the Transaction.
4. The parties may execute this agreement in counterparts, each of which together shall be deemed the complete and fully executed agreement.
