TRADEMARK ASSIGNMENT

This Trademark Assignment (this “**Assignment**”) is made effective as of September 19, 2019 (the “**Effective Date**”), by Jeffrey Jan, an individual residing in Tarrant County, Texas (“**Assignor**”) and Frontline Advance LLC, a Texas limited liability company with offices at 1070 S. RECITALS

Section 1. Assignment. Assignor hereby irrevocably transfers, assigns, conveys and delivers to Assignee the entire world-wide right, title and interest in and to the Trademarks, including, without limitation, all associated goodwill, all applications, renewals, registrations, substitutions, extensions and foreign counterparts thereof, and all other corresponding rights that are or may be secured under the laws of the United States, any foreign country or jurisdiction or any multilateral organization, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, all claims for damages and the right to sue for, collect, settle or release any past, present or future infringement of any of the Trademarks. Assignor does hereby authorize and request the Commissioner of Patents and Trademarks of the United States of America or equivalent authority elsewhere in the world to record this Assignment.

Section 2. Assistance. From time to time, as and when requested by Assignee, Assignor shall execute and deliver, or cause to be executed and delivered, all documents and instruments and shall take all other actions as Assignee may reasonably request to consummate the transactions contemplated by this Assignment. Further, at Assignee’s expense, Assignor and its successors and assigns shall testify in any legal proceedings, sign all lawful papers, make all lawful oaths and perform all lawful acts reasonably necessary and proper to vest title to the Trademarks in Assignee and to aid Assignee, its successors, assigns and legal representatives to obtain and enforce proper protection for the Trademarks.

Section 3. Counterparts. This Assignment may be executed in multiple counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same agreement. The parties intend to treat as an original any document signed in connection with the transactions contemplated by this Assignment, including any counterpart to this Assignment or any related document that is delivered by electronic transmission, including by facsimile, PDF, photo static copy, or otherwise.
