RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), dated as of September 19, 2019, is made by **U.S. BANK NATIONAL ASSOCIATION**, a national banking association ("Secured Party"), and is as follows:

WHEREAS, ARY, Inc., a Missouri corporation ("Debtor"), and Secured Party are parties to that certain Trademark Security Agreement dated as of June 17, 2019, which was recorded with the United States Patent and Trademark Office on June 17, 2019, in its records at Reel 6671, Frame 0784 (the "Agreement"); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to Secured Party a security interest in all of Debtor's right, title and interest in, to and under the Trademark Collateral, including, without limitation: (a) all of Debtor's now or in the future owned or existing trademarks, service marks, trademark or service mark registrations, trade names, and trademark or service mark applications (exclusive of any Intent to Use Applications), including each mark, registration, and application listed on Schedule I attached hereto and made a part hereof (the property in this item (a) being, each, a "Trademark," and collectively, the "Trademarks"); (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all of the Trademarks, including damages and payments for past or future infringements of any and all of the Trademarks; (d) all rights to sue for past, present and future infringements of any and all of the Trademarks; (e) all rights corresponding to each of the Trademarks throughout the world; (f) all rights of Debtor as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark registrations and service mark registrations and applications, including the licenses listed on Schedule I and the Trademark Licenses By Debtor; and (g) together in each case with the goodwill of Debtor's business connected with the use of, and symbolized by, any of the foregoing in this definition of Trademark Collateral; and


WHEREAS, Secured Party desires to release its rights and security interests in, and liens on, the Trademark Collateral.
