**RELEASE AND TERMINATION
OF TRADEMARK ASSIGNMENT OF SECURITY**

THIS RELEASE AND TERMINATION OF TRADEMARK ASSIGNMENT OF SECURITY, dated as of August 14, 2019 (this "Release"), is made by GOLDMAN SACHS BDC, INC., a Delaware corporation, acting in its capacity as agent (in such capacity, the "Agent") under that certain Trademark Assignment of Security, dated as of May 16, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the "Trademark Assignment"), by and among STACI CORP., a Delaware corporation ("STACI"), VEXOS, INC. (formerly known as CLP ST, Inc.), a Delaware corporation ("Vexos"), Inservco, Inc., an Ohio corporation ("Inservco" and together with STACI and Vexos, collectively, the "Grantors", and each a "Grantor") and the Agent.

WHEREAS, pursuant to the Trademark Assignment which was recorded in the records of the United States Patent and Trademark Office on May 16, 2014 at reel 5282, frame 0139, the Grantor granted to the Agent a continuing security interest in all of the Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademarks, including those set forth on the attached Schedule I (the "Trademark Collateral");

WHEREAS, pursuant to that certain Payoff Letter, dated as of August 14, 2019 by and between the Grantors, the other signatories party thereto and the Agent, the Grantors have requested and the Agent has agreed to (a) release any and all security interests it may have in the Trademark Collateral pursuant to the Trademark Assignment and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Assignment in the Trademark Collateral, (b) release and relinquish its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademark Collateral. The Agent agrees, or authorizes the Grantors, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantors to evidence the release and termination of the Agent's security interests in the Trademark Collateral.


