GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS


This grant is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantor, as such term is defined in the Pledge and Security Agreement among the assignors from time to time party thereto as grantors and the Grantee, dated as of May 8, 2017 (as modified by the Joinder (as defined below) and as otherwise amended, modified, restated, amended and restated and/or supplemented from time to time, the "Security Agreement"), to which the Grantor was joined pursuant to that certain Joinder Agreement, dated as of May 17, 2017 (the "Joinder"). Upon the termination of the Security Agreement, the Grantee shall execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Trademarks acquired under this grant.

This grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of each Grantee with respect to the security interest granted herein are set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


