RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of September 26, 2019 (this "Release") is made by SUNTRUST BANK, as administrative agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for the Secured Creditors (as defined in the Security Agreement referred to below) in favor of BER Energy Services, LLC, a Texas limited liability company (the "Grantor").

Pursuant to the Security Agreement, dated as of April 13, 2017 entered into by the Grantor, each other grantor party thereto, and Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Grantor and Administrative Agent entered into a certain ABL Trademark Security Agreement, dated as of April 13, 2017 and recorded in the United States Patent and Trademark Office on April 13, 2017, at Reel 6034, Frame 0978 (the "Trademark Security Agreement"), and pursuant to the Security Agreement and Trademark Security Agreement, Grantor granted to the Administrative Agent for the benefit of the Secured Creditors a lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including the foregoing identified on Schedule A hereto and incorporated herein by reference.

The Administrative Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the grant of and all of its lien on and security interest in, all right, title and interest in, to and under the Trademark Collateral granted under the Trademark Security Agreement, including the foregoing identified on Schedule A hereto and incorporated herein by reference. Any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void. This Release does not terminate, release or discharge the Administrative Agent's security interest in any intellectual property or any other asset of the Grantor other than the Trademark Collateral.

3.

The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary and requested by Grantor to effect the release of the security interest contemplated hereby, at Grantor's expense. The Administrative Agent hereby authorizes the Grantor or the Grantor's authorized representative to record this Release with the United States Patent and Trademark Office.


