1. I am the President and Chief Executive Officer of DuBois Chemicals, Inc., a Delaware corporation, and I am authorized to make this Affidavit herein. My experience and responsibilities and review of company records give me personal knowledge of the matters set out in this affidavit and I could testify competently to such matters.

2. I was the President and Chief Executive Officer of DuBois Chemicals, Inc. from 2008 to Present. The statements made herein are within my personal knowledge and, if called to testify thereto, I would be competent to do so.

3 On June 28, 1989, Park Chemical Company, a predecessor-in-interest to DuBois Chemicals, Inc., granted a Security Interest in Trademarks to Security Pacific National Bank to the subject trademarks:
