RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE, dated as of September 30, 2019 is made by U.S. BANK NATIONAL ASSOCIATION, a national banking association (“**Secured Party**”), for itself and as administrative agent for the Lenders (as defined in the Credit Agreement referenced below), under the Security Agreement dated as of September 29, 2016 (as amended, restated, supplemented, or otherwise modified from time to time, the “**Security Agreement**”) by and between the Secured Party and Cowboy Charcoal, LLC, a Kentucky limited liability company with an address of 2894 Monte Diablo Ave, Stockton, CA 95203 (“**Grantor**”), and recorded on September 30, 2016, in the records of the U.S. Patent and Trademark Office at Trademark Reel 5888 Frame 0248.

WHEREAS, Duraflame, Inc., a California corporation (“**Borrower**”), the Lenders, and the Secured Party are parties to that certain Credit Agreement dated as of September 29, 2016, (as amended, restated, supplemented, or otherwise modified from time to time, the “**Credit Agreement**”) pursuant to which Lenders agreed, among other things, to extend to Debtor certain credit accommodations.

WHEREAS, Grantor granted certain security interests to the Secured Party under the Security Agreement, including but not limited to all of the Trademarks set forth on Exhibit A now owned or from time to time after the date thereof owned or acquired by Grantor (the “**Trademarks**”).

WHEREAS, Secured Party wishes to: (i) release and terminate all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to Grantor; and (iii) terminate any and all liens and encumbrances respecting the Trademarks under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Lender hereby releases and terminates its security interest in the Trademarks and discharges, quit claims and relinquishes unto the Grantor (in each case without recourse and without representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement, effective as of the date set forth above.
