## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Trademark Assignment Agreement"), dated as of October 1, 2019, is by and between WorldVentures Foundation ("Assignor"), and Nancy Lieberman Charities ("Assignee").

WHEREAS, Assignor and Assignee had entered into that Partnership Agreement, dated as of May 15, 2015 (the "Partnership Agreement");

WHEREAS, in association with the Partnership Agreement, Assignor held a 50% interest in the U.S. registered trademarks forth on Exhibit A (the "Trademarks");

WHEREAS, the Partnership Agreement was terminated as of September 1, 2017, and Assignor and Assignee agree that all rights, title and interest in and to the Trademarks (as defined below) should be held by the Assignee; and;

WHEREAS, Assignor and Assignee now seek to confirm and consummate such assignment of the Trademarks.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee, intending to be legally bound hereby, agree as follows:

1. Assignment. Assignor hereby irrevocably conveys, assigns, transfers and delivers to Assignee and its successors and assigns its entire right, title and interest in and to the Trademarks, together with any and all goodwill connected with and symbolized by the foregoing, the same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, as assignee of its respective entire right, title and interest therein, including all rights in and to all income, royalties, damages and payments now or hereafter due or payable with respect thereto, all causes of action (whether in law or in equity) with respect thereto, and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this Trademark Assignment Agreement.
2. Filing and Recordation. The parties hereto agree that Assignee shall promptly file and record this Trademark Assignment Agreement, or the equivalent of this Trademark Assignment Agreement to the extent required, with the appropriate governmental entities as necessary to record Assignee as the assignee and owner of the Trademarks. Assignor and Assignee authorize and request that the United States Patent and Trademark Office record Assignee as the assignee and owner of the Trademarks (set forth on Exhibit A).
3. Successors. This Trademark Assignment Agreement shall inure to the benefit of and is binding upon the respective successors and assigns of Assignor and Assignee.


4. Governing Law. This Trademark Assignment Agreement shall be governed by and construed in accordance with the laws of the State of Delaware without giving effect to the conflict of laws rules thereof.
5. Counterparts. This Trademark Assignment Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original but all of which together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page of this Trademark Assignment Agreement by facsimile or by PDF file (portable document format file) shall be as effective as delivery of a manually executed counterpart of this Trademark Assignment Agreement.


