**TRADEMARK RELEASE OF SECURITY INTEREST**

This TRADEMARK RELEASE OF SECURITY INTEREST (this “Release”) is made as of October 15, 2019, by BMO HARRIS BANK, N.A., as Administrative Agent (“Secured Party”) in favor of HERITAGE FOOD SERVICE GROUP, INC., a Delaware corporation (“Grantor”).

WHEREAS, Grantor has requested that Secured Party discharge and release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the intellectual property described therein including, but not limited to, the Trademarks set forth on Exhibit A and the Trademark Collateral and reassign the same to Grantor;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor’s right, title and interest in, to and under Trademark Collateral.

To the extent, if any, that following the release as set forth in Section 1 above, Secured Party retains or would retain any right, title or interest in or to the Trademark Collateral or any goodwill of any business conducted in connection therewith, Secured Party hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Secured Party, all of Secured Party’s right, title and interest in, to and under the Trademark Collateral, and the goodwill of Grantor’s business connected with the use of and symbolized by the Trademark Collateral.


