Trademark Assignment

This Trademark Assignment by and between Lumeris Solutions Company, LLC ("LSC"), a Delaware limited liability company, and Lumeris Healthcare Outcomes, LLC ("LHO"), a Missouri limited liability company (either one individually as a "Party" or together as the "Parties"), both Parties having their principal place of business at 13900 Riverport Drive, Maryland Heights, MO 63043, is made as of the latest date of the execution of the Parties below.

WHEREAS, LSC owns the entire right, title, and interest in and to the US trademark registration MAESTRO, having serial number 85153886 and registration number 4051917 (the "Mark"), and is desirous of assigning all of its rights in and to the Mark to LHO; and,

WHEREAS, LHO is desirous of acquiring all of LSC's right, title, and interest in and to the Mark via assignment from LSC;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Parties, LSC hereby conveys to LHO, and LHO hereby accepts from LSC, all of LSC's right, title, and interest in and to the Mark, together with the goodwill of the business symbolized in the Mark, with all rights to sue and recover for damages and/or profits for past infringements.


The registration for the above Mark is for the following goods and services in class 42: *"application service provider featuring software for aggregating insurance claim, pharmacy, laboratory and other pertinent data from across the continuum of care within a database, and for analyzing such data to provide actionable output information and decision support to insurance companies, physicians and other organization stakeholders within a provider network; none of the foregoing relating to credit cards, debit cards, payment cards, automatic teller machines (ATMs), point of sale payment terminals, ATM services, electronic funds and currency transfer services, credit services, banking services, payment services or other products and services in the financial services field."*


