**ARTICLES OF AMENDMENT**

GREATER MARYLAND HEALTH SYSTEM, INC., a Maryland nonstock corporation having its principal office in Anne Arundel County, Maryland (hereinafter referred to as the "Corporation"), hereby certifies to the State Department of Assessments and Taxation of Maryland ("SDAT") that:

**FIRST**

The Corporation desires to amend its charter as currently in effect for purposes of changing its name from "Greater Maryland Health System, Inc" to "Luminis Health, Inc" The remaining provisions of the charter shall remain in effect as filed with and approved by SDAT on July 1, 2019. Therefore, the charter of the Corporation is hereby amended by striking out in its entirety Article FIRST of the existing charter and substituting in lieu thereof the following:

**FIRST** The name of the corporation (the "Corporation") is

**LUMINIS HEALTH, INC."**

**SECOND**

The amendments to the Corporation's charter as set forth in these Articles of Amendment were duly approved, adopted, and advised by a majority of the Board of Trustees of the Corporation, who are also all of the Members of the Corporation, and such acts were the only corporate action necessary under applicable law to adopt these Articles of Amendment.

**THIRD**
