
WHEREAS, Assignee wishes to acquire all rights, title and interest in and to the Trademarks and the Registrations;

Assignor will assist Assignee as reasonably necessary to secure, perfect, maintain or evidence the rights hereby transferred.


This Agreement may be executed in two or more counterparts, each of which will be deemed an original but all of which shall together constitute one and the same instrument.
