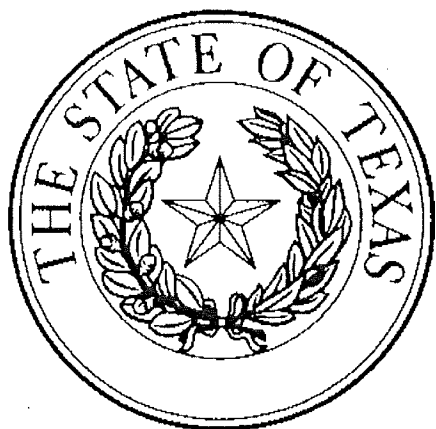

Pursuant to the provisions of Sections 10.101 and 10.154 of the Texas Business Organizations Code (the "TBOC"), Code Authority, Inc., a for-profit corporation formed and existing under the laws of the State of Texas (the "Converting Entity"), does hereby adopt and submit this Certificate of Conversion for the purpose of converting into Code Authority, LLC, a Texas limited liability company (the "Converted Entity").

1. The name, form of organization, jurisdiction of formation, date of formation and the file number issued to the Converting Entity by the Secretary of State of the State of Texas are:

in connection therewith and will be obligated to pay all fees and franchise taxes if they are not timely paid.

10. This conversion of the Converting Entity to the Converted Entity becomes effective when this Certificate of Conversion is accepted and filed by the Secretary of State of the State of Texas.

CERTIFICATE OF FORMATION
OF
LIMITED LIABILITY COMPANY

The undersigned, having the capacity to contract and acting as sole organizer of a filing entity under the Texas Business Organizations Code (the "TBOC"), does hereby adopt the following Certificate of Formation:

Article 1 - Entity Name and Type

The filing entity being formed is a limited liability company. The name of the filing entity is Code Authority, LLC (the "Company").

The filing entity is being formed under a Plan of Conversion adopted by Code Authority, Inc. (the "Converting Entity"). The name and principal address of the Converting Entity is Code Authority, Inc., 3001 Dallas Parkway, Suite 500, Frisco, Texas 75034 (USA). The Converting Entity was incorporated and currently exists as a for-profit corporation under the laws of the State of Texas. The date of incorporation of the Converting Entity in the State of Texas is January 25, 2001. The file number assigned to the Converting Entity by the Secretary of State of the State of Texas is 161392400.

Article 2 - Registered Agent and Registered Office

The street address of the Company's registered office in the State of Texas is 2001 Ross Avenue, Suite 4250, Dallas, Texas 75201 (USA), and the name of the Company's registered agent at such address is Cheryl L. Small.

Article 3 - Governing Authority

The powers of the Company shall be exercised by or under the authority of, and the business and affairs of the Company shall be managed under the direction of, managers or a sole manager. The name and address of the initial sole manager of the Company are as follows:

Article 4 - Purpose

The purpose for which the Company is formed is to engage in any lawful business for which limited liability companies may be formed under the TBOC, subject to any limitations thereon or more restrictive statement thereof that may be set forth in the Company's company agreement.

Article 5 - Period of Duration

The period of duration of the Company is perpetual, unless the existence of the Company is terminated in accordance with the provisions of the TBOC or the Company's company agreement.

Article 6 - Limitation of Liability

A manager of the Company shall not be liable to the Company or its members for monetary damages for an act or omission in the manager's capacity as a manager, except that this Article 6 does not eliminate or limit the liability of a manager to the extent the manager is found liable for (i) a breach of the manager's duty of loyalty to the Company or its members; (ii) an act or omission not in good faith that constitutes a breach of duty of the manager to the Company; (iii) an act or omission that involves intentional misconduct or a benefit, whether or not the benefit resulted from an action taken within the scope of the manager's responsibilities; or (iv) an act or omission for which the liability of a manager is expressly provided by an applicable statute. Any repeal or amendment of this Article 6 by the members of the Company shall be prospective only and shall not adversely affect any limitation on the liability of a manager of the Company existing at the time of such repeal or amendment. In addition to the circumstances in which a manager of the Company is not liable as set forth in the preceding sentences, each manager shall not be liable to the fullest extent permitted by any provision of the statutes of Texas hereafter enacted that further limits the liability of a manager or of a director of a corporation.


