
WHEREAS, WSP agrees to sell and transfer the Trademark and all associated goodwill therein to NEWBERG; and

WHEREAS, NEWBERG desires to acquire all rights, title and interest in and to the Trademark, along with its goodwill and the Trademark Registration.


**AGREEMENT**
