**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Release") is executed as of November 4, 2019, by JPMorgan Chase Bank, N.A., as Administrative Agent and Collateral Agent (in such capacities, together with its successors, "Secured Party"), in favor of RMNJ Licensing LLC, a Delaware limited liability company (the "Released Party").


