TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks (the "Termination and Release"), dated October 28, 2019, is executed by CITIZENS BANK, N.A., as Administrative Agent (the "Lender") under that certain Revolving Demand Credit Agreement dated as of May 26, 2017 (the "Credit Agreement") among Simonds Saw L.L.C., a Delaware limited liability company, having an address at 135 Intervale Road, Fitchburg, MA 01420 (the "Borrower"), Simonds Holding, Inc., a Delaware corporation (the "Parent Guarantor") and the Lender, having an address at 28 State Street, Boston, MA 02109.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Lender hereby terminates and releases all of its security interest in the Trademarks.
2. The Lender authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable United States government officer record this Termination and Release.
3. This Termination and Release shall be governed by the laws of the Commonwealth of Massachusetts.

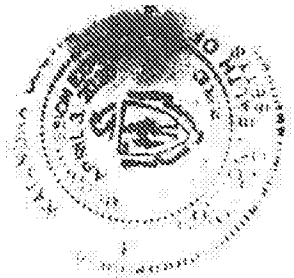
