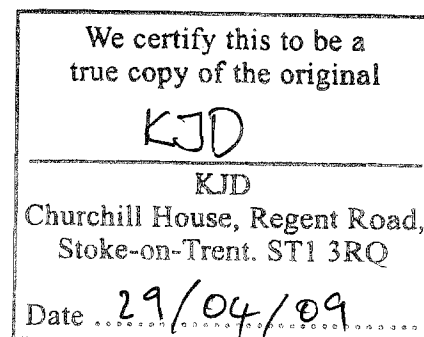

By **BURDALE CAPITAL FINANCE, INC** ("Lender").

BACKGROUND

- (A) By the various securities set out in **Schedule 1** to this deed ("Securities") THE PORCELAIN AND FINE CHINA COMPANIES LIMITED (in Administration) ("Company") (company number 00597983) whose registered office is c/o PricewaterhouseCoopers LLP of Benson House, 33 Wellington Street, Leeds, LS1 4JP charged the properties, undertaking and assets, as described in the Securities, in favour of the Lender to secure the performance of all obligations mentioned in the Securities.
- (B) The Lender has agreed to release the assets referred to in **Schedule 2** to this deed ("Released Assets") from the Security.

OPERATIVE PROVISIONS

1. Subject to the conditions stated in this deed, the Lender now irrevocably releases, surrenders and reassigns the Released Assets to the Company free and clear of all charges, security rights and interests whatsoever constituted by the Securities and all monies secured by and from all claims and demands under the Securities.
2. Nothing contained in this deed shall prejudice or affect the security of the Lender under the Securities in respect of the remaining property and assets charged by them nor, as between the Lender and the Company, in respect of the proceeds of sale of the Released Assets payable to or received by the Company which proceeds shall remain subject to the Securities pending discharge and redemption thereof.
3. The Lender shall at the request and reasonable cost of Portmeirion Potteries Limited ("the Purchaser"), execute any deed or document and take any further action reasonably required by the Purchaser to fully release the Released Assets from the Securities.
4. The provisions of this deed shall not be enforceable by any party other than the Lender, the Company and its administrators and the Purchaser under the Contracts (Rights of Third Parties) Act 1999.
5. This deed shall be governed by and construed in accordance with the laws of England.

THIS DOCUMENT is executed as a deed and delivered on the date stated at the beginning of this Deed.

The Security


The security interest of the Lender executed 31 August 2007 and recorded on 13 September 2007 at the United States Patent and Trademark Office and all other security interests of the Lender over or in respect of the Released Assets.
