TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST ("Termination and Release") dated as of November 12, 2019, is made from JPMORGAN CHASE BANK, N.A. WHEREAS, the Lender now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Borrower;


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:
