**CERTIFICATE OF MERGER
AND CANCELLATION**

Pursuant to Section 61 of the Massachusetts Limited Liability Company Act, the undersigned entities executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is **BoardOnTrack, Inc.**, a Delaware corporation formed on February 23, 2015 by filing a Certificate of Incorporation with the Delaware Secretary of State ("Corporation"), and the name of the limited liability company being merged into this surviving corporation is **The High Bar, LLC**, a Massachusetts limited liability company formed on March 26, 2010 (the "LLC").

SECOND: The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by the board of directors of the surviving corporation in accordance with Section 251(f) of the Delaware General Corporation Law and the members of the merging limited liability company in accordance with Section 60 of the Massachusetts Limited Liability Company Act. No shares of stock of the surviving corporation were issued prior to the adoption of the Agreement and Plan of Merger by the board of directors of the surviving corporation.

THIRD: The name of the surviving corporation is **BoardOnTrack, Inc.**

FOURTH: The merger is to become effective upon the filing of the Certificate of Merger with the Secretary of State of the State of Delaware.

FIFTH: The Agreement and Plan of Merger is on file at 9 Damonmill Square, Suite 5A-1, Concord, Massachusetts 01742, the place of business of the surviving corporation.

SIXTH: A copy of the Agreement and Plan of Merger will be furnished by the surviving corporation on request, without cost, to any stockholder of any constituent corporation or member of any constituent limited liability company.

SEVENTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.

EIGHTH: The Corporation, as the surviving entity, agrees that, if it does not continually maintain an agent for service of process in the Commonwealth of Massachusetts, to appoint irrevocably the Secretary of the Commonwealth to be its true and lawful attorney upon whom all lawful process in any action or proceeding in the Commonwealth may be served in the manner set forth in M.G.L. Chapter 156c, Section 61(a)(7).

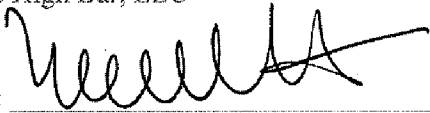

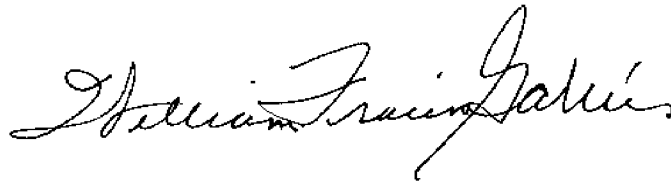
