Release of Confirmatory Grant of Security Interest in Trademarks

THIS RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Release") is granted as of November 25, 2019, to AMERCARE ROYAL, LLC, a Pennsylvania limited liability company (formerly known as Royal Paper Products, LLC, which merged with AmerCare, LLC) (the "Grantor"), to and in favor of U.S. BANK NATIONAL ASSOCIATION, a national banking association (the "Secured Party") for itself and as administrative agent for the Lenders (as defined in the Credit Agreement referenced below).

WHEREAS, Grantor's predecessor in interest AmerCare, LLC ("AmerCare") and AmerCare Parent, LLC, a Delaware limited liability company (the "Parent", and together with the Grantor, each, a "Borrower," and collectively, the "Borrowers"), the Lenders, and the Secured Party are parties to that certain Credit Agreement of even date herewith (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement") pursuant to which the Lenders agree, among other things, to extend to the Borrowers certain credit accommodations.

WHEREAS, AmerCare granted security interests to the Secured Party under the Pledge and Security Agreement and Irrevocable Proxy on April 17, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, the Grantor owns the trademarks (the "Trademarks") listed on Exhibit A, which are registered or applied for with the United States Patent and Trademark Office ("PTO");

WHEREAS, pursuant to the Security Agreement, AmerCare executed and delivered a Confirmatory Grant of Security Interest in Trademarks dated as of April 17, 2014 (the "Collateral Assignment") granting the Secured Party a security interest in and lien on the Trademarks;

WHEREAS, the Collateral Assignment was recorded with the PTO against the Trademarks on April 23, 2014, at Reel 5266, Frame 0532; and

WHEREAS, the Grantor has satisfied all of the obligations under the Security Agreement and has requested that the Secured Party terminate and release its security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:


- 1) Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in the Credit Agreement.
- 2) Release of Security Interest. The Secured Party hereby terminates, releases, and discharges its security interest in and liens on the Trademarks.

3) Reassignment. The Secured Party hereby reassigns, grants, and conveys to the Grantor without any representation, recourse, or undertaking by the Grantor, all of the Secured Party's right, title, and interest in and to the Trademarks.
