ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT (this "Agreement"), dated as of June 7, 2019, is by and among TPC Wire & Cable Corp., a Delaware corporation (the "Purchaser"), EZ Form Cable Corporation, a Connecticut corporation ("EZ Form"), Volpe Technology, LLC, a Connecticut limited liability company ("Volpe Technology"), Volpe Leasing, LLC, a Connecticut limited liability company ("Volpe Leasing", and together with EZ Form and Volpe Technology, the "Companies" and each a "Company"), Frank A. Volpe, an owner of EZ Form, Volpe Technology, and Volpe Leasing, Michele Volpe, as trustee under the Frank A. Volpe 2012 Family Spray Trust Agreement, dated November 16, 2012, which Trust is an owner of EZ Form (the "Volpe Trust"), and Francesca Volpe, an owner of Volpe Technology and the beneficiary of the Volpe Trust (Frank A. Volpe, the Volpe Trust and Francesca Volpe are each an "Owner", and collectively, the "Owners"). Capitalized terms used herein and not otherwise defined have the meanings given to such terms in Article VII below.

3.10. Intellectual Property Rights.

To the Knowledge of Companies EZ Form is not subject to any obligation, including any license or royalty obligation, relating to any product or service that EZ Form now markets or has marketed. Except as set forth on Schedule 3.10(a), EZ Form solely and exclusively own all rights, title, and interest and to, and are the owner of record of the Owned IP, and have valid and enforceable right to use and exploit all other Business IP, in each case free and clear of all Liens. Neither the Business IP nor the conduct of the Business as conducted prior to Closing, infringes or conflicts upon the right of any third party. To the Knowledge of the Companies, no third party is infringing or has engaged in any activity that infringes, misappropriates, constitutes unlawful use of, conflicts with, or otherwise violates any Business IP; and EZ Form has not asserted any claims relating to, or made any offer for license related to, such activity against any person.

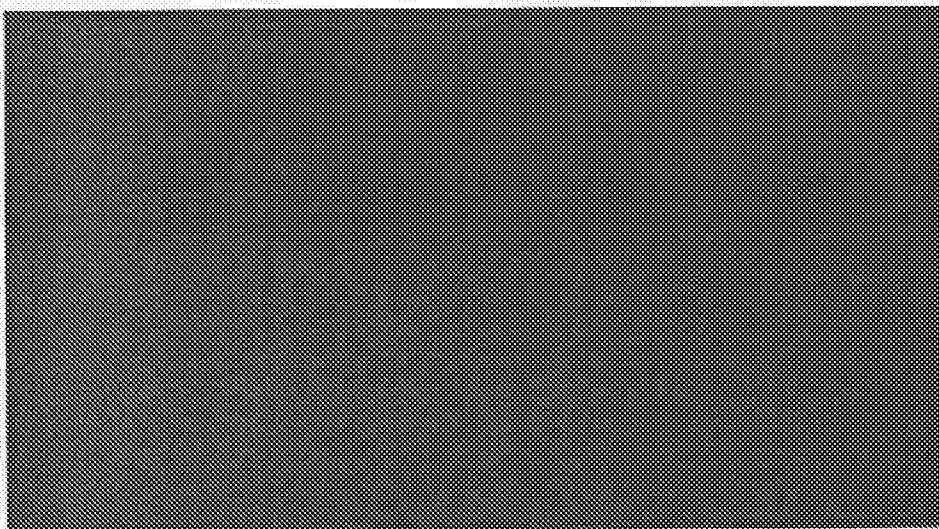

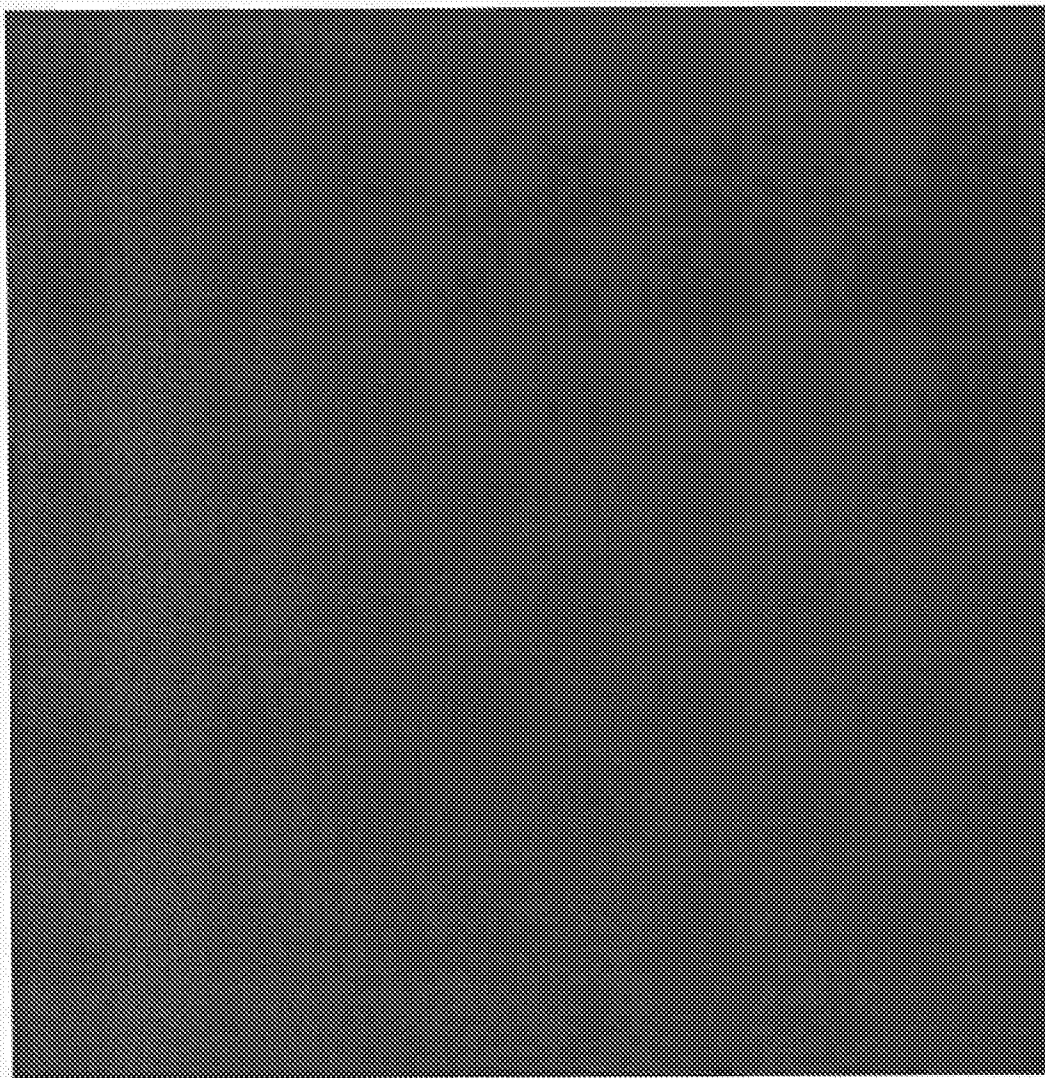


