CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS

This CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS (the "Confirmatory Grant") is made effective as of December 2, 2019, by and from New Freedom Holdings, LLC ("New Freedom") and Dr. Patrick J. Carnes ("Dr. Carnes" and, together with New Freedom, "Grantor"), to and in favor of The Meadows of Wickenburg, Inc. ("Grantee").

WHEREAS, Grantor and Grantee are party to that certain Supplement IV to Intellectual Property License Agreement, dated as of December 2, 2019 ("Supplement IV");

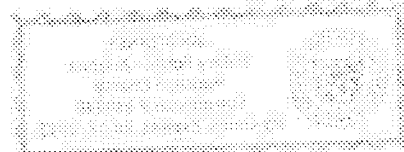
WHEREAS, Grantor owns the trademarks listed on Exhibit A attached hereto (the "Trademarks");

WHEREAS, this Confirmatory Grant has been granted in conjunction with the security interest granted to Grantee under Supplement IV. The rights and remedies of Grantee with respect to the security interest granted herein are without prejudice to and are in addition to those set forth in Supplement IV, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Confirmatory Grant are deemed to conflict with Supplement IV, the provisions of Supplement IV shall govern.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in Supplement IV or incorporated therein by reference.
2. The Security Interest.
 - (a) This Confirmatory Grant is made to secure the satisfactory performance of Grantor pursuant to the Agreement.
 - (b) The Grantor hereby grants to Grantee a security interest in (1) all of Grantor's right, title and interest in and to the Trademarks now owned or from time to time after the date hereof owned or acquired by the Grantor, together with (2) all proceeds and products of the Trademarks, (3) the goodwill associated with such Trademarks, and (4) all causes of action arising prior to or after the date hereof for infringement of the Trademarks or unfair competition regarding the same.
3. Choice of Law. This Confirmatory Grant shall be governed by and construed in accordance with the laws of the State of Arizona.
5. Counterparts. This Confirmatory Grant may be signed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

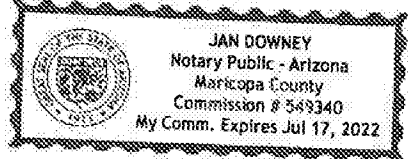
