## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "**Agreement**") dated as of March 1, 2017 (the "**Effective Date**"), is entered into between KINETESCAPE HOLDINGS, LLC, a Delaware limited liability company ("**Assignor**"), and KINETESCAPE STEAM AND POWER, LLC, a Delaware limited liability company ("**Assignee**", and each of Assignor and Assignee, a "**Party**").

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to accept and assume, all of Assignor's entire right, title and interest in and to the Trademarks (as defined below), together with the goodwill associated therewith, to correct an error in the identification of the Owner.

NOW, THEREFORE, for the mutual covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. **Assignment.** Assignor hereby irrevocably transfers and assigns to Assignee, and Assignee hereby accepts and assumes from Assignor, Assignor's entire right, title, interest and goodwill in and to (i) the trademarks set forth in Schedule A hereto, and (ii) any registration or application for registration of any of the foregoing (including the registrations and applications for registration set forth in Schedule A hereto (collectively, the "**Trademarks**").

2. **Cooperation.** Assignee shall, and shall cause its employees, affiliates, successors and assigns to, execute all documents and take all additional steps reasonably necessary to effectuate the intent of this Agreement, including recording the Assignment with the USPTO and paying all associated fees and costs.

3. **General Provisions.** This Agreement may not be supplemented, altered, or modified in any manner except by a writing signed by the Parties.
