RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") dated as of December 16, 2019, is made by U.S. BANK NATIONAL ASSOCIATION, a national banking association ("Bank"), for the benefit of OREGON ICE CREAM, LLC, a Delaware limited liability company ("Obligor").

RECITALS

A. WHEREAS, Obligor granted to Bank a continuing security interest and lien in all of Obligor's trademarks listed on **Exhibit A** attached hereto (collectively, the "Trademarks"), which such security interest was established by, among other things, that certain Trademark Security Agreement dated June 25, 2013, between Bank and Obligor and recorded with the United States Patent and Trademark Office (the "USPTO") on July 22, 2013, at Reel 5075, Frames 0184-0189; as amended by that certain Amended and Restated Trademark Security Agreement dated December 11, 2017, between Bank and Obligor and recorded with the USPTO on December 21, 2017 at Reel 6233, Frames 0350-0355; and

B. WHEREAS, Bank desires to release and reassign to Obligor all interest that Bank may have in the Trademarks.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Bank hereby releases its security interest in the Trademarks and reassigns to Obligor all interest of Bank in the Trademarks.
