TRADEMARK SECURITY AGREEMENT RELEASE

This Trademark Security Agreement Release (this “Release”) is made effective as of December 16, 2019, by Obsidian Agency Services, Inc., in its capacity as collateral agent (“Collateral Agent”) in favor of Fidelis Cybersecurity, Inc. (successor to Resolution1 Cybersecurity LLC) (the “Grantor”).

Reference is hereby made to that certain Trademark Security Agreement, dated as of May 4, 2015 (the “Agreement”) by Grantor in favor of Collateral Agent recorded with the United States Patent and Trademark Office on May 4, 2015 at Reel/Frame 5509/0750.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases, terminates and discharges the lien on, security interest in and mortgage on the Collateral (as defined in the Agreement) of the Grantor pledged and granted under the Agreement, including without limitation such lien on, security interest in and mortgage on the Trademarks and Trademark Licenses (as defined in the Agreement) set forth on Annex A attached hereto and all Proceeds (as defined in the Agreement) of the foregoing.

If and to the extent the Collateral Agent has acquired any right, title or interest in and to the Collateral under the Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right title or interest to the Grantor.

The Collateral Agent authorizes and request that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
