1. I am the CEO of Center-Moeller Products LLC (“**Center-Moeller**”).
2. I am properly authorized to execute this Declaration on behalf of Center-Moeller and I have firsthand knowledge of the facts stated herein. All statements made of my own knowledge are true and all statements made on information and belief are believed to be true.
3. On April 4, 2011, U.S. Trademark Registration No. 1,123,586 for the mark EASY-GRIP (the “**Registration**”) was assigned from Moeller Products Co., Inc. to Center-Moeller. This assignment is recorded with the United States Patent and Trademark Office (“**USPTO**”) at Reel 4514, Frame 0909. A copy of the assignment records for the Registration is attached hereto as **Exhibit A** and reflects the recording of this assignment as Assignment #4.
4. On November 20, 2017, a trademark assignment dated May 26, 2017 purporting to assign the Registration from The Moore Company to Inca Products Acquisition Corp. was recorded with the USPTO (the “**Purported Assignment**”). The Purported Assignment is recorded at Reel 6205, Frame 0559 and is reflected on Exhibit A as Assignment #9.
5. The Purported Assignment was processed by the USPTO even though there is a clear break in the chain of title.

6. At the time the Purported Assignment was recorded with the USPTO, the Registration was held in the name of Center-Moeller. Thus, the purported assignor, The Moore Company, did not have the authority or ability to assign the registration to the purported assignee, Inca Products Acquisition Corp.

7. There is no assignment transferring the Registration from Center-Moeller to The Moore Company recorded with the USPTO.


