1 DEFINITIONS & INTERPRETATIONS

- 1.2 Whenever a party to this Agreement comprises more than one person, the obligations on those persons shall be joint and several.

2 ASSIGNMENT

- 2.1 In consideration of the sum of £1 (receipt of which the Assignor hereby acknowledges) the Assignor **HEREBY ASSIGNS** to the Assignee with full title

guarantee the Trade Marks together with all the Assignor's rights and interests in respect thereof (including the goodwill associated with the business related to the Trade Marks and without limitation the right to sue in respect of any past infringements) **TO HOLD** unto the Assignee **ABSOLUTELY**.

3 REGISTRATION OF NEW PROPRIETORSHIP

The Assignor agrees with the Assignee at the direction and expense of the Assignee to execute any further document that the Assignee may reasonably require to enable the Assignee to become registered by the Registrar of Trade Marks or other relevant authority as the proprietor of the Trade Marks .

4. ASSIGNOR'S WARRANTIES AND INDEMNITY

The Assignor warrants that:

- 4.1 The Assignor is the proprietor of the Trade Marks and has full power to enter into this Assignment
- 4.2 The Assignor has not granted any assignments by way of security, charges or licences in relation to the Trade Marks

5. PROPER LAW AND JURISDICTION


