## ASSIGNMENT OF TRADEMARK

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer the Assigned Trademark to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct and, at Assignee's cost, to record and register this Assignment Agreement upon request by Assignee, its successors, assigns and legal representatives, or to such nominees as it may designate. Assignor shall, at Assignee's cost, take such steps and actions following the date hereof, including the execution of any documents, files, registrations, or other similar items, to ensure that the Assigned Trademark is properly assigned and transferred to Assignee, or any assignee or successor thereto. Assignor further agrees that, until the Assigned Trademark is transferred to Assignee, Assignor shall maintain the Assigned Trademark in full force and effect.
3. Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment Agreement.
4. This Assignment Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. This Assignment Agreement may not be amended except by an instrument in writing signed by each of the Parties hereto.
5. This Assignment Agreement shall be binding upon and shall inure to the benefit of the Parties hereto and the Parties' respective successors and assigns.


