
ASSIGNOR hereby authorizes ASSIGNEE to take all necessary and/or appropriate steps to effectuate this Assignment, including the recordation thereof.

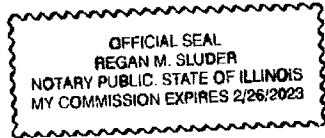
