TRADEMARK ASSIGNMENT

AGREEMENT made as of December 16, 2019 (the "Effective Date") by and between, 360 Logic d/b/a Coregenx, a Delaware limited liability company having a place of business at 9881 Irvine Center Drive, Suite 200, Irvine, CA 92618 ("Assignor") and Vital Proteins LLC, a Delaware limited liability company having a place of business at 3400 Wolf Road, Franklin Park, IL 60131 ("Assignee").

WHEREAS, Assignor is the owner of U.S. Federal Trademark Registration No. 5,417,698 for the mark "game changer" for use in connection with goods in International Class 005, which registration issued on March 6, 2018 (the "Trademark"), and further is the sole and exclusive owner of all common law trademark and trade dress rights and business goodwill associated therewith;

WHEREAS, Assignee desires to acquire Assignor's entire worldwide right, title, and interest in and to the Trademark, and all business goodwill associated therewith, and in fact has acquired such interest by virtue of payment of a sum certain to Assignor as set forth in a separate Domain Name Transfer Agreement.

Be it known that in consideration of the payment by Assignee to Assignor of the sum of ten dollars (\$10,00) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, and transfers unto Assignee its entire worldwide right, title and interest in and to the Trademark, and the business goodwill associated therewith, including, without limitation, all renewals therefore, all proceeds therefrom (including, but not limited to, all license royalties and proceeds of infringement suits), the right to sue for past, present, and future infringements, and the goodwill of the business associated with and symbolized by the Trademark.
