ASSIGNMENT OF TRADEMARK ASSETS

WHEREAS, Tuthill Corporation, a Delaware corporation (“Assignor”), and Eaton Corporation, an Ohio corporation (“Purchaser”), among others, have entered into a Stock and Asset Purchase Agreement dated as of December 15, 2010 (the “Agreement”); and

WHEREAS, under the Agreement, Assignor agreed to convey to Purchaser, all right, title and interest in and to the Purchased Assets, including all Acquired Intellectual Property (as those terms are defined in the Agreement); and

WHEREAS, as permitted by Section 11.7 of the Purchase Agreement, Purchaser has assigned its rights, interests and obligations with respect to the Purchased Assets to its Affiliate, Eaton Aeroquip LLC, an Ohio limited liability company (“Assignee”); and

WHEREAS, Assignor owns all right, title and interest in and to the federal and state trademark registrations and applications therefor listed in Schedule A hereto that comprise part of the Purchased Assets, and all renewals thereof or thereon (hereinafter, collectively, the “Trademarks”); and

WHEREAS, Assignee is desirous of acquiring all of Assignor’s right, title and interest in and to all Trademarks, and Assignor has promised, in the Agreement, to cause the same to be assigned; and

NOW, THEREFORE, for the consideration set forth in the Agreement, and other valuable and legally sufficient consideration acknowledged by the Assignor to have been received in full:

1. The Assignor does hereby sell, convey, assign, transfer and deliver to the Assignee its entire right, title and interest in, to and under all Trademarks, together with the goodwill of the business symbolized by such Trademarks, together with all rights and privileges granted and secured thereby, including the full right to sue for past, present or future infringement of such Trademarks, these rights to be held and enjoyed by the Assignee as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment and sale had not been made.

2. The Assignor hereby covenants that it has full right to convey the entire interest herein assigned and agrees to execute any and all documents reasonably required to effect this Assignment.


3. The terms and covenants of this Assignment shall inure to the benefit of the Assignee, its successors and assigns and other legal representatives, and shall be binding upon the Assignor, its respective heirs, legal representatives and assigns.

4. The Assignor hereby requests that the appropriate patent, trademark or other government offices record this Assignment and issue a new certificate of registration in the Assignee’s name.

5. This Assignment does not (i) convey any rights of Assignor other than those required to be transferred under the Agreement, (ii) create any obligations for Assignor in addition to those provided under the Agreement, or (iii) relieve Assignor of any obligations under the Agreement.
