TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement") is entered into as of January 2, 2020, between the following two parties.

The Assignor: Stryx Men, LLC

WHEREAS, the Assignor agrees to assign the USPTO trademark registration for the mark STRYX, Registration No. 5753500 and all the goodwill associated with the mark (hereinafter the "Trademark") to the Assignee and the Assignee agrees to accept the assignment of the Trademark.

NOW, THEREFORE, in consideration of the above recitals and the mutual promises and conditions contained in this Agreement, the Parties agree as follows:

1. Assignment and Transfer of Trademark Registration

The Assignor hereby agrees to assign all rights and interest in USPTO trademark registration for the mark STRYX, Registration No. 5753500 along with the goodwill associated with said mark (hereinafter the "Transfer") and Assignee agrees to accept the Transfer. As full and final consideration for the Transfer the Assignee shall pay the Assignor One United States Dollar (\$1.00). The Assignor further agrees to change the recorded owner of the Trademark into the Assignee's name and the Assignee agrees to accept the change of the recorded owner of the Trademark.


2. Registration Fees

The assignment for the change of the recorded owner of the Trademark shall be undertaken by the Assignor and the Assignee shall bear the registration fees incurred hereby.

3. Applicable Law

The validity, interpretation and implementation of this Agreement shall be governed by the laws of the State of New York.
