Pursuant to the provisions of Section 253 of the General Corporation Law of the State of Delaware (“*DGCL*”), The Bureau of National Affairs, Inc., a Delaware corporation (“*Parent*”), **DOES HEREBY CERTIFY:**

FIRST: that Parent was incorporated in the State of Delaware pursuant to the provisions of the DGCL on the December 7, 1946.

SECOND: that Parent owns at least 90% of all the issued and outstanding capital stock of Tax Management Inc. (“*Subsidiary*”), a corporation incorporated in the State of Delaware pursuant to the provisions of the DGCL on August 14, 1959.

THIRD: that Parent, by a resolution of its Board of Directors duly adopted by unanimous written consent pursuant to Section 141(f) of the DGCL, filed with the minutes of its Board of Directors and with an excerpt attached hereto as **Exhibit A**, approved the merger of Subsidiary with and into Parent, with Parent as the surviving corporation (the “*Merger*”).

FOURTH: that the Merger shall become effective upon the filing of this certificate of ownership and merger with the Secretary of State of the State of Delaware.

FIFTH: that the surviving corporation in the Merger shall be Parent (the “*Surviving Corporation*”) and the separate existence of Subsidiary shall cease. The certificate of incorporation of Parent in effect immediately prior to the Merger shall continue in full force and effect as the certificate of incorporation of the Surviving Corporation.

FROM THE UNANIMOUS WRITTEN CONSENT
OF THE BOARD OF DIRECTORS
OF

Dated December 20, 2019

WHEREAS, [The Bureau of National Affairs, Inc. (the "Company") and Tax Management Inc. ("TM") have reached agreement as to the merger of the TM with and into the Company with the Company as the surviving company (the "Merger"), among other things, pursuant to that certain Agreement and Plan of Merger (together with all exhibits, schedules and attachments thereto, the "Merger Agreement"), a draft of which is attached [to such resolutions];

WHEREAS, [the board of directors of the Company] hereby determines that the Merger Agreement and the transactions contemplated thereby, including without limitation, the Merger, are advisable, fair to and in the best interests of the Company and the sole stockholder of the Company;

NOW, THEREFORE, BE IT

RESOLVED, that the Company be, and hereby is, authorized to enter into, and hereby adopts and approves (i) the Merger Agreement, (ii) the Merger and (iii) the transactions and documents contemplated by the Merger Agreement;
