The undersigned, as an authorized person of the Converting Corporation and the Company, does hereby certify as follows:

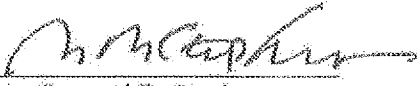

**DECLARATION OF MARK EDWARDS**

1. COMES NOW the declarant, Mark Edwards, who being duly sworn deposes and says as follows:

2. My name is Mark Edwards. I am the Chief Financial Officer of Bradford Health Services, LLC, the parent company of Addiction & Mental Health Services, LLC f/k/a Addiction & Mental Health, Services, Inc. (the "Registrant"), which has registered the design mark identified above, BRADFORD HEALTH SERVICES (the "Mark"). I have personal knowledge of the matters stated herein and have legal authority to bind the Registrant.

3. On June 30, 2016, Addiction & Mental Health Services, Inc., an Alabama Corporation, filed a Certificate of Conversion to convert the entity to Addiction & Mental Health Services, LLC, a Delaware Limited Liability Company.

4. On July 25, 2003, Wachovia Bank National Association (as Successor to First Union National Bank, a National Banking Association, which was f/k/a First Union National Bank of North Carolina erroneously filed a Release of Security Agreement against the Mark as to Medical World Business Press, Inc. (A Successor by Merger with Dental Learning Systems Co., Inc., A Delaware Corp. which was f/k/a Dental Learning Systems Acquisition Co., Inc., a Delaware Corp.), which is a New Jersey Corporation.

5. Registrant has not identified Addiction & Mental Health Services, Inc. as a New Jersey Corporation to the United States Patent and Trademark Office ("USPTO"), and any filings identifying Registrant as a New Jersey Corporation were filed in error. Upon Registrant's belief, Registrant anticipates that the USPTO lists its state of organization as New Jersey due to Wachovia's aforementioned erroneous filing.


6. Therefore, the Registrant respectfully requests the USPTO change the current owner's state of organization to Delaware as set forth by the Certificate of Conversion.
