Assignor hereby assigns to Assignee all of Assignor's right, title, and interest, including all common law and statutory rights, and any and all federal and state registrations, in and to the Marks, together with (a) all of the goodwill and business embodied in and symbolized by the Marks, and (b) all causes of action, claims, and demands or other rights for, or arising from, any infringement, including past infringements, of the Marks. Assignor shall not, at any time after the date hereof, claim any right, title or interest to the Marks.

2. This Assignment is made by Assignor without any representation or warranty of any kind, either express or implied, all of which are hereby expressly disclaimed by Assignor.

3. Assignor further agrees, without further consideration, execute such further assignments and other lawful documents as Assignee may from time to time reasonably request to assist Assignee with the registration and/or enforcement of the Marks and to effect fully this assignment and to permit Assignee to be duly recorded as the registered owner or proprietor of each of the rights hereby conveyed.

4. For corporate and federal income tax purposes, it is intended that the Marks will be treated as (i) first, distributed to the members of Assignor and (ii) then, transferred by such members to Assignee. For administrative convenience, the members of Assignor shall direct Assignor to hereby assign the Marks to Assignee.
